





Terms and Conditions of Sale SMELTEC 2024

1.- Order:

The submission of an order by a buyer implies acceptance of these general conditions of sale. The clauses appearing on the order of this purchaser and contrary to our general conditions of sale cannot be opposed to us.

The purchaser commits himself respecting the conditionings stipulated on the tariff and their multiples. Our footwear items are sold from size 35 to 50 and packaged by 10 pairs size by size. The products of maintenance are sold by boxes of 24 units.

2.- Prices :

Our prices are exclusive of VAT

Our prices are indicated EXWORKS (ex-factory)

Franco CEE: 1500 € excluding taxes.

No minimum order, shipping costs will be charged to the customer below the CEE shipping.

Our invoices are established in euros

3.- Delivery :

The normal shipping time is 10 working days upon receipt of the order (on stock).

Please consult us for volumes over 2000 pairs.

Delivery times are given to the buyer as an indication only, they start to run from the date when our services are in possession of all the documents necessary for the execution of the order.

A delay in delivery shall not be considered as a reason for breach of contract of sale nor shall it give rise to payment of damages or penalties for delay. The seller reserves the right to make split deliveries.

Buyer must verify shipments upon arrival. If the goods have been damaged during transport,

the buyer will make all necessary reserves and claims against the carrier.

The buyer must confirm these reserves to the carrier by registered letter within 3 days of receiving the goods. In the case of modifications of the purchaser's situation (change of structure, default or delay in payment, bankruptcy, dissolution, death), we reserve the right to suspend deliveries, to demand guarantees or, failing that, to cancel the orders. No goods may be returned without our consent. The shipping costs are at the buyer's expense.

4.- Payment :

All our invoices are payable at our head office: Carrer Gaspar Fabregas i Roses, 61 - 08950 Esplugues de Llobregat (Spain). Payment within 60 days of the date of invoice (article L441-6 of the commercial code modified by the law "LME" from 04/08/2008) Payment within 10 days of the date of invoice, amount credited to our bank account CIC Est: discount 1,5% Payment in advance: discount 2%.

Payment dates must be respected by the buyer, even if transport or delivery is delayed for reasons beyond the control of the seller.

5.- Interests :

If the payment is not resolved by the due date, the seller reserves the right to claim interest in an amount equal to 3 times the legal interest rate in force at the date of the invoice.

6.- Retention clause of ownership

The goods travel at the recipient's risk, even in the case of carriage paid by the seller. The property of the delivered goods is reserved to us until the complete payment of the price, expenses and accessories. By express agreement, we reserve the property of the goods until the last day of their complete payment.

7.- Jurisdiction Clause:

The parties shall endeavor to settle amicably any dispute arising from the current general conditions of sale.

If within a period of one month from the notification of one of the parties to the other of the existence of the dispute, no amicable solution could be established between the parties, the dispute will be brought to the attention of the competent. If any dispute is established between the parties, the dispute shall be referred to the competent courts of Barcelona (Spain). Any order implies implicit acceptance of these terms and conditions.
